## **Special Education Assessment Partnership Feedback**

- Education Psychologists were on-site in Moosonee and Moose Factory for 4 days in May
- One full day was spent at MPS and 6 assessments were completed, estimated that approximately 4-6 students are in need of assessments in the fall of 2023
- CYMS stores extra materials for visiting Psychologists, which enabled two extra assessments to be completed at MPS on this visit
- NLSS was able to have 2 assessments completed, at this time no assessment needs have been identified
- Usually Psychologist visit in October, February and May, discussion about tightening up communication / scheduling with schools, CYMS and Psychologists the fall
- Concern raised about wait times for reports and all agreed this is an excellent partnership

#### **New Business:**

- Increase IPRC involvement at MPS, choice was provided to participate in-person or by calling in, meeting focused on a review of student successes for the year. NLSS participated in grade 8 IPRC meetings as part of the transition process to secondary school
- Grade 8 transition day, took place on May 30<sup>th</sup> and went very well again this year, also the mini skills trades workshops that the feeder school grade 8 students had participated in during the month of May were very successful

#### Other Business:

- Voluntary CanChild research study surveys are being distributed by mail to parents / guardians at MPS.
  Participation in this study allowed for an Occupational Therapist (OT) to work within MPS to identify needs and teach skills such as pencil grip, scissor use, tying shoes and more. The OT partnership has supported whole class and small group activities and staff training this year
- New special education model at NLSS with having a designated SERT support for gr. 9/10 and designated SERT support for gr. 11/12 has been very successful in fostering relationships and improving engagement in student learning supports and supporting student needs
